Indigo Data Communications Ltd is committed to achieving Net Zero emissions by 2045

Baseline Emissions Footprint

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured.

Baseline Year: 2022

Additional Details relating to the Baseline Emissions calculations.

This is the first Baseline Emissions Assessment for Indigo Data Communications Ltd.

As part of Indigo's environmental footprint strategy, Indigo will measure, minimize and report on the company's environmental footprint including undertaking rigorous annual measurement. Indigo's reporting includes absolute emissions and will compare Indigo's performance to previous reporting periods and tracks progress against Indigo's targets. Indigo's greenhouse gas (GHG) emissions are calculated in line with the GHG Protocol. Indigo's methodology follows best practices, such as using internationally accepted conversion.

- Scope 1 encompasses direct emissions, including those associated with the direct consumption of
 natural gas, heating oil, and diesel fuel as well as the emissions associated with owned and leased
 vehicles and fugitive emissions. Scope 1 emissions are mainly calculated based on volumes of
 consumed.
- Scope 2 encompasses indirect emissions, including those associated with the purchase and consumption of local electricity. Scope 2 emissions are mainly calculated based on volumes of purchased and consumed electricity.
- Scope 3 encompasses other indirect emissions, such as business travel and production of
 purchased goods and services (including cloud services and video conferencing), vehicles not
 owned or controlled, outsourced activities, employee commuting (including teleworking), and
 waste disposal. Scope 3 emissions are mainly calculated based on stay duration (hotels), spend
 (purchased goods and outsourced activities), technology usage (cloud services and video
 conferencing), estimates of employee travel and home energy consumption (employee
 commuting and teleworking), and industry benchmarks (waste disposal).



The Scope 3 figures reported in this CRP include only the following sources of emissions as per the Technical Standard guidance: upstream transportation & distribution; waste generated in operations; business travel; employee commuting; and, downstream transportation and distribution.

 - o We have made it mandatory to use WEEE certified suppliers within our supply chain for disposals.
 - o We will Invest in the monitoring and reporting of carbon emissions of our organisation, supply chain, and the solutions we deliver to the customer.

- Transition to electric vehicles reducing vehicle emissions.
- Paperless environment resulting in a reduction in the use of natural resources and a reduction in waste.
- We will convert our office lighting to LED lights resulting in reduced electricity use.

- Offsetting Carbon Footprint through participation in tree planting scheme.
- Improved analysis and working with suppliers to reduce Scope 3 emissions.
- Investigate waste reduction initiatives.
